1.0 Policy Statement

Under the Smoke-Free Ontario Act, all Ontario hospital indoor and outdoor grounds must be completely smoke-free. Smoking is prohibited at all St. Joseph's Healthcare Hamilton (SJHH) Campuses, including gardens, parking lots, in parked cars on our sites and within 9 metres (approximately 29 feet) of hospital entrances and exits. This also includes St. Joe's owned properties that house off-site programs and services throughout the province. This policy is a reflection of the Smoke-Free Ontario Act and applies to all instances where any individual is located on hospital property.

2.0 Purpose

The health hazards of tobacco use are well established and recent evidence of the effects of passive smoking indicate increased health risks in non-smokers. In accordance with the Smoke-Free Ontario, and as such prohibits smoking of Tobacco and Cannabis on all hospital-owned Campuses and properties. Tobacco products are defined as: all cigarettes, e-cigarettes, vapes, cigars, pipe tobacco, snuff, chewing tobacco, herbal cigarettes, contraband tobacco products and any other like product that contains a health warning from Health Canada or has not been approved by the Canadian Drug Administration (CDA). Cannabis products are defined as marijuana (medical and nonmedical/recreational). Smoking is prohibited in personal vehicles when parked on properties owned, leased or managed by SJHH. SJHH strives to provide a healthy smokefree hospital environment to ensure that those who work, visit or receive care are not exposed to the health risks associated with second-hand smoke. At SJHH, a safe, hazardfree workplace includes clean air. Additionally, as a facility with a mental health and addiction program, it is important that SJHH be smoke-free in order to provide a nontriggering environment for staff and patients/ clients, and visitors struggling with various stages of addiction.

3.0 Expectations

All members of leadership, including senior management, directors, and supervisors are responsible for clearly communicating the Smoke-Free Ontario Act to all staff, physicians, learners, volunteers, contractors, visitors and patients/clients.

- **3.1** All staff, physicians, learners, volunteers, contractors, visitors and patients/clients are expected to continually support and represent SJHH's commitment to maintain a smoke-free environment.
- **3.2** Signage will be posted in visible areas throughout SJHH (internally and externally) to communicate the Smoke-Free Ontario Act to all persons.

4.0 Responsibilities

4.1 Staff, Physicians, Learners, Volunteers, Contractors:

- a) On admission or as soon as possible, the relevant aspects of the Smoke-Free Ontario Act will be reviewed with all patients/clients and their families, or with those individuals who accompany a patient/client.
- **b)** Will inquire whether the patient/client smokes and document on the *Tobacco Use Inpatient Form* (refer to documentation).
- **c)** Are to remind patients/clients and visitors of the *St. Joe's Smoke-Free Policy*.

d) Are not to accompany patients/clients to smoke or assist them with smoking.

SJHH employees that are found violating the Smoke-Free Ontario Act on SJHH Campus and property will be subject to progressive discipline according to existing policies and the Smoke-Free Ontario Act. Failure to comply with the Act will result in stepped disciplinary action.

4.2 Patients/Clients:

- **a)** Are not permitted to smoke on SJHH Campuses and properties.
- **b)** Are not permitted to leave hospital premises to smoke while wearing or transporting any hospital equipment.
- c) May choose to give tobacco and/or cannabis products to a friend or family member for safekeeping. Staff are not permitted to store or provide tobacco or non-medical recreational cannabis products to patients/clients.
- **d)** Who do not comply with the Smoke-Free Ontario Act are to be respectfully reminded of the Act and requested to stop smoking immediately.

4.3 Visitors:

- **a)** Are not permitted to smoke on SJHH Campus and property, as outlined by the Smoke-Free Ontario Act and this policy.
- **b)** Are asked not to supply patients/clients with smoking products.
- **c)** Those who do not comply with the Smoke-Free Ontario Act are to be respectfully reminded of the Act and requested to stop smoking immediately.
- **d)** Failure to comply with this Act will result in the visitor being escorted off the Campus/property by Security Professionals at SJHH.

5.0 Enforcement

Failure to comply with the Smoke-Free Ontario Act will be enforced by Security Professionals at SJHH.

Security Professionals on SJHH owned property will be responsible for enforcing, documenting and reporting Smoke-Free Ontario Act infractions by staff, physicians, learners, volunteers, contractors, patients/clients, visitors or any other individual found smoking on hospital property (refer to section 3.0-Responsibilities). For Smoke-Free Ontario Act infractions, Security Professionals at SJHH will complete a Witness Report and fax to the Hamilton Public Health Services (Refer to documentation). In addition, City of Hamilton/Public Health

Enforcement Officers will perform inspections of all hospital Campuses and off-site owned properties.

Under the Smoke-Free Ontario Act, an individual found to be smoking on hospital property in Ontario can face a maximum **fine of \$1,000** (for a first offence.) If a hospital in Ontario fails to fulfill its responsibility under the law, the hospital could face a maximum fine of **\$100,000** for a first offence, or **\$300,000** for any further offence.
